

EXAM APPLICATION FEES & DEADLINES

Pay by **credit card, debit card** or send a **money order, cashier's check, corporate check or law firm check** made payable to "**Clerk of the Supreme Court.**" Do **not** send a personal check.

All fees are non-refundable.

In the event that any of the filing deadlines should fall on a Saturday, Sunday, or a legal holiday, that deadline will be extended until the end of the next business day.
